RESOLUTION NO. 2009- 8

A RESOLUTION OF WAYNE TOWNSHIP, LAWRENCE COUNTY, COMMONWEALTH OF PENNSYLVANIA, A SECOND CLASS TOWNSHIP, INCREASING THE COMPENSATION OF THE OFFICE OF THE TAX COLLECTOR TO INCLUDE 2.5% OF TAXES LEVIED AND ASSESSED AND SUBMITTED TO THE LAWRENCE COUNTY TAX CLAIM BUREAU.

WHEREAS, the Office of the Tax Collector of Wayne Township currently receives compensation in the form of a 5% commission on the taxes levied, assessed and collected by the office without the need to file or submit the same to the Lawrence County Tax Claim Bureau;

WHEREAS, the Wayne Township Board of Supervisors recognizes the work and effort of the Office of the Tax Collector in the performance of its duties whether such taxes are collected and prior to their submission to the Lawrence County Tax Claim Bureau;

WHEREAS, the Office of the Tax Collector previously did not receive compensation for taxes which were not collected prior to their submission to the Lawrence County Tax Claim Bureau;

WHEREAS, the Wayne Township Board of Supervisors desires to pay to the Office of the Tax Collector, as an additional form of compensation, 2.5% of the taxes levied and assessed but not collected and submitted to the Lawrence County Tax Claim Bureau.


NOW THEREFORE, be it resolved by the Board of Supervisors of Wayne Township, Lawrence County, Pennsylvania, in its meeting assembled on February 5, 2009, as follows:

1. The Board of Supervisors hereby increases the compensation of the Office of the Tax Collector to include 2.5% of taxes levied and assessed but not collected prior to their filing and submission with the Lawrence County Tax Claim Bureau.
2. This increase is in addition to the compensation in the form of a 5% commission for those taxes assessed, levied and collected by the Tax Collector. This percentage commission will not change.
3. This Resolution is effective for taxes levied and assessed subsequent to the 2009 municipal election and thereafter.


